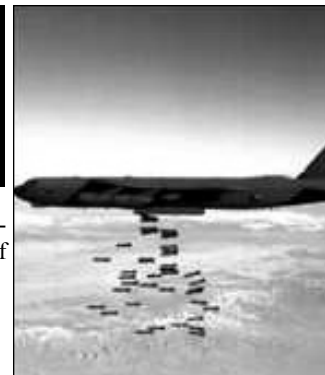


# Two Years on Trial at NATO's Court in The Hague

The International Criminal Tribunal for the Former Yugoslavia (ICTY) plans to complete the two-year-long prosecution's case against former Yugoslav President Milosevic in the last week of February. Now, due to the resignation of Chief Judge Richard May, due to health, there may be grounds for a mistrial.

### Panel Discussion

**Former U.S. Attorney General Ramsey Clark**, will speak on his recent letter to the United Nations challenging the legality of the proceedings. Clark demands a moratorium on all cases before the International Criminal Tribunal on the Former Yugoslavia.

**Prof. Barry Lituchy** International Committee for the Defense of Slobodan Milosevic (ICDSM-U.S.) and History Professor, Kingsborough Community College (CUNY). Lituchy recently attended part of the trial and will speak on the failure of the prosecution's case, the injustice of the process.

**Sara Flounders** of the International Action Center. Flounders will describe the ongoing effort to expose the U.S. government's lies about the wars in Yugoslavia in the light of the expose of the lies to justify the war against Iraq.
